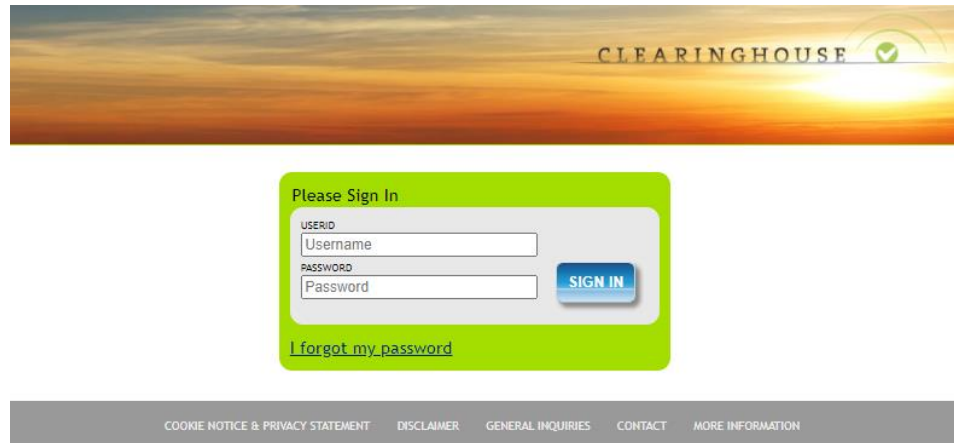
1. Introduction

This guide will provide you with the necessary steps on how to reset your Trademark Clearinghouse password.



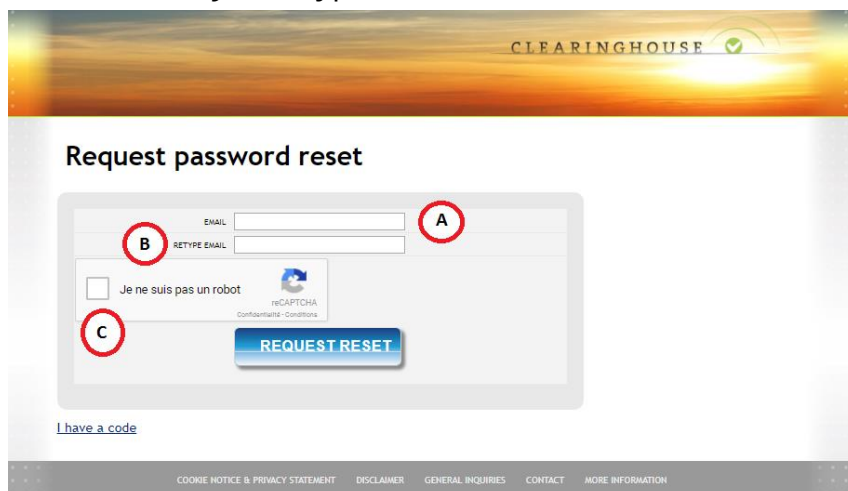
2. Password reset process

To initiate the password reset process, click on the “I forgot my password” button provided on the [Sign In page](#) as shown in the image below:



You will then be required to complete the following fields:

- Email address (*mandatory*): The e-mail address supplied by the contracting party during the registration process (A).
- Re-type email address (*mandatory*): The e-mail address supplied by the contracting party during the registration process. Please make sure this is the same email address as provided in the “Email” field (B).
- Security token (*mandatory*): Re-type the reCAPTCHA (C).



In case both entered email addresses are not identical, you will be requested to re-enter them.

To confirm the password reset, you will need to tick the box of the reCAPTCHA and then press the “Request reset” button.

If successful, you will receive an email as the following one:

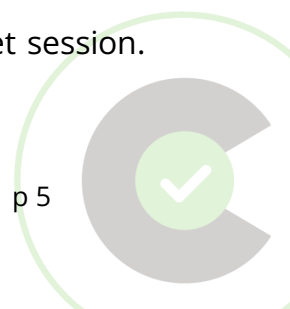

The code field is automatically filled in and is a unique ID of the password reset session. You will then be required to complete the other following fields:



- Email address (*mandatory*): The e-mail address supplied by the contracting party during the registration process. Please make sure this is the same email address as the one with which you requested the password reset (A).
- Security token (*mandatory*): Re-type the reCAPTCHA (B).

After completing the fields, you must click on the “Request reset” button to confirm.

In case all fields have been completed correctly, you will receive a last email containing your user ID and your new temporary password:

Password policy

- The password is case-sensitive.
- The password must be made up of at least 8 characters.
- The password must contain at least 4 alphabetic characters.
- The password must contain at least 2 non-alphabetic characters.
- Any character of the password can not be repeated more than 2 times.
- A new password can be used for a period of 91 days. After this period, the user must change it.

Once you have clicked on “Change password”, your password has been updated.
