1. Introduction

This guide provides a comprehensive overview of the different types of accounts available for both Agents and Holders, along with their respective benefits. It details the steps required to create an account in the Trademark Clearinghouse. Furthermore, the guide explains our range of services, including the Sunrise service, which enables registration in newly launched TLDs during the priority registration period; the Claims notification service, which alerts both domain name registrants and Trademark Holders of potential infringements; and the Ongoing notification service, which offers continuous alerts of possible intellectual property infringements beyond the Claims period. Finally, the guide provides information on how to contact our customer support team for any assistance you may need.



2. Who can apply?

Any Trademark Holder (private person or company) or Trademark Agent (acting on behalf of Trademark Holders) can submit a trademark record in the Trademark Clearinghouse.

2.1. Trademark Holders

Trademark Holders are individuals or entities and their designees (such as licensees or assignees) that have, or wish to have, their eligible trademark rights included in the Trademark Clearinghouse. A Trademark Holder can submit a trademark record on their own behalf or can submit a trademark record through a Trademark Agent as described below.

2.1.1. Types of Trademark Holders

There are two types of Trademark Holders within the TMCH:

- Trademark Holder: Registers their own trademarks and pays a fee base of 155 USD per entry with a credit card.
- Trademark Holder (Prepay): Also registers their own trademarks but makes a 15.000 USD deposit, which is fully redeemable to purchase any of our services. The remaining balance is refundable upon contract termination.

2.2. Trademark Agents

Trademark Agents are individuals or entities authorized to act on behalf of Trademark Holders. They manage the submission and maintenance of trademark records and handle all related communications and notifications concerning TMCH services on behalf of the Trademark Holders.



2.2.1. Types of Trademark Agents

There are two types of Trademark Agents within the TMCH:

- Trademark Agent (Gold): Receives branded marketing material and pays a prepayment fee of 15.000 USD. This deposit is fully redeemable for purchasing any of our services. The remaining balance is refundable upon contract termination.
- Trademark Agent (Silver): Does not receive any branded marketing material and pays a non-refundable prepayment fee of 5.000 USD which is fully redeemable to purchase any of our services.

2.2.2. Benefits for Trademark Agents


- Earn Status Points with every trademark registration or renewal. Accumulated points can be redeemed to reduce the fees for future trademark registrations and renewals.
- Your company will be featured on our Official Agent page, making it easy for Trademark Holders to find and contact you directly.
- Receive complimentary marketing materials to support your promotional efforts.
- Benefit from a dedicated account manager who will assist you with any queries throughout the trademark submission process and beyond.



3. How to create an account?

3.1. Trademark Holder

Step 1: Navigate to the Trademark Clearinghouse [marketing website](#), scroll down and click on the “Create an Account” button to start the registration process. You can also use the ‘Sign Up’ button in the top right corner or navigate directly to the [registration page](#).



Step 2: Make sure to have your Trademark Certificate ready. The contracting party information you enter in the registration form will be used in the trademark records you submit. Therefore, it is important to provide details that exactly match those on the Trademark Certificate in the ‘Who is the contracting party’ section.



Note: The e-mail address you enter here will be the primary address used to send all communications, including notifications and customer support information.

Step 3: After completing all the mandatory fields with the information exactly as shown on your Trademark Certificate, please select the type of account you wish to create.

As a Trademark Holder, you have two options:

- Trademark Holder: You will only be registering your own marks and pay by credit card.
- Trademark Holder (Prepay): You will only register your own marks and will have to make an initial deposit of 15.000 USD. This deposit can be used to cover trademark record registrations fees in the Trademark Clearinghouse and any additional extras,



such as a charge of 1 dollar per label exceeding the standard 10 labels. Please note, this is a prepayment, not a subscription fee.



Step 5: Once all steps are successfully completed and your request has been validated, you will receive a confirmation email containing your username and temporary password.








Terms and Conditions of the Clearinghouse Trademark Holders

These Clearinghouse Validation Terms and Conditions for Trademark Holders (these "Clearinghouse Validation Terms and Conditions") are between CHIP S.A., having its registered office at 24 rue Léon Laval, L-3372 Leudelange, Luxembourg (hereinafter "CHIP" or "we" or "us") and the undersigned, as a Trademark Holder ("you"), pursuant to which you are submitting a Trademark Record (as defined below) for inclusion in the trademark clearinghouse established by the Internet Corporation of Assigned Names and Numbers (the "Trademark Clearinghouse") as part of the New generic Top-Level Domain Program ("New gTLD Program").

Preamble

Whereas, The Trademark Clearinghouse is part of the New gTLD Program and one of the rights protection mechanisms established by ICANN.

Whereas, The Trademark Clearinghouse consists of two primary functions: (i) the authentication of



If you disagree with any such changes, you have the right to terminate your Agreement and get a refund of your remaining balance in accordance with section VI.6. No waiver of any provision of this Agreement shall be binding unless evidenced by a writing signed by the party waiving compliance with such provision. No waiver of any of the provisions of this Agreement or failure to enforce any of the provisions hereof shall be deemed or shall constitute a waiver of any other provision hereof, at law or in equity, nor shall any such waiver constitute a continuing waiver unless otherwise expressly provided.
6. Except for Deloitte, ICANN and the Database Provider, no other person shall have any rights, interest or claims hereunder or be entitled to any benefits under or on account of this Agreement as a third-party beneficiary or otherwise.




Step 8: Log out and sign in with your new password.

- Holder Prepay: You can download the pro-forma invoice by clicking the “Pro-Forma Invoice” button. Please note that to complete your registration, a wire transfer of 15.000 USD is required. Additionally, note that any bank or transaction fees must be borne by the holder as we require the full amount of 15.000 USD to be received in our account. For detailed instructions on the wire transfer process, kindly refer to Section 4.

3.2. Trademark Agent

Step 1: Navigate to the Trademark Clearinghouse [marketing website](#), scroll down, and click on the 'Create an Account' button to start the registration process. You can also use the 'Sign Up' button in the top right corner or navigate directly to the [registration page](#).

Step 3: After completing all the mandatory fields, please select the type of account you want to create.

As a Trademark Agent, you have two types of accounts (as previously stated in 2.2.1):

- Trademark Agent (Gold): Receives branded marketing material and pays a prepayment fee of 15.000 USD. The outstanding amount of the prepayment fee is refundable, in the event that a Gold Trademark Agent terminates its contract with the TMCH.
- Trademark Agent (Silver): Does not receive any branded marketing material and pays a prepayment fee of 5.000 USD which is non-refundable upon contract termination.







Password policy

- The password is case-sensitive.
- The password must be made up of at least 8 characters.
- The password must contain at least 4 alphabetic characters.
- The password must contain at least 2 non-alphabetic characters.
- Any character of the password cannot be repeated more than 2 times.
- A new password can be used for a period of 91 days. After this period, the user must change it.




Step 7: After changing your password, click on the “contract” button.



You will be redirected to the following page, where you can download the following two documents:

- Your personal Trademark Agent contract: Please complete the signing by e-signature or by printing the document, signing it manually, and re-submitting it.
- The pro-forma invoice provides all payment details required for your wire transfer of the prepayment deposit. As noted earlier, the minimum deposit is 15.000 USD for Gold Agents and 5.000 USD for Silver Agents. This deposit can be used to cover trademark record registrations fees in the Trademark Clearinghouse and any additional extras, including extra correction chances, transfer fees, and charges of 1 dollar per label exceeding the standard 10 labels. Please note, this is a prepayment, not a subscription fee. Gold Agents may receive a refund of any unused balance if the contract is terminated.



Once we have received the signed contract and the prepayment deposit, you will receive a confirmation email. You will be able to log in to start submitting trademark records. Please note that any bank or transaction fee must be borne by the payer.



4. How to top up the Prepaid Account?


4.1. Initial Deposit

When you register for a Prepayment Account, an initial pro-forma invoice will be generated for the initial deposit, including the wire transfer details.

Please ensure that you include your user ID (which begins with a "U") in the payment reference. Omitting this information may result in delays in processing your payment.

Kindly instruct your financial institution that you will cover all transaction and currency conversion fees. If these costs are not borne by you, they will be deducted from the transferred amount. Should the minimum initial deposit not be met due to such deductions, your account will not be activated.

Once we have received the funds, you will be able to download the final invoice via 'My Account' > 'List of Invoices'. The funds deposited will then be immediately available for submitting trademark records.



All payments can be made to our bank account as per section 4.3.



4.2. Top-ups

When topping up your Prepayment Account, please wire transfer the desired amount to our bank account. Always include your user ID (starting with a “U”) in the payment reference. Failure to do so may result in delays in processing your payment. Each top-up must be for a minimum of 1.000 USD. Please instruct your financial institution that you will bear all transaction and currency conversion fees.

If these costs are not covered by you, they will be deducted from the transferred amount, which may result in an insufficient balance to complete all required actions.

All payments should be made to our bank account as detailed in section 4.3.

5. Services

This section will provide you with an overview of all services included in the Trademark Clearinghouse.

5.1. Sunrise Service

By having your or your clients' trademarks verified by the Trademark Clearinghouse, you are able to register with newly launched TLDs during the priority registration period (Sunrise). The Sunrise period is a period of at least 30 days and is only accessible to right owners (Trademark owners), verified by the Trademark Clearinghouse. Trademark owners can take advantage of this priority-registration period to safeguard the domain name that matches their trademark ahead of general availability.

5.2. Trademark Claims Service

The Trademark Claims service follows the Sunrise period. It is a notification service, mandated by ICANN for all new gTLDs, to warn both domain name registrants as well as Trademark Holders of possible infringements. This service can be activated by right owners (Trademark owners or UDRP/Court Cases).

The service works as follows:

- A potential domain name registrant receives a warning notice when attempting to register a domain name that matches a trademark record listed in the Trademark Clearinghouse.
- If the registrant proceeds with the registration after receiving and accepting the notice, the Trademark Holder with the corresponding mark in the TMCH will be notified of the domain name registration. This allows the Trademark Holder to take any appropriate action if they wish to do so.



This notification service is mandated by ICANN for all new gTLDs during the first 90 days of general availability. After the 90-day period, TMCH clients benefit from the Ongoing Notifications (see the next paragraph for further details) at no extra cost.

5.3. Ongoing Notifications Service


Following the initial 90-day Trademark Claims Period for each new gTLD, the Trademark Clearinghouse operates the Ongoing Notifications service. This service ensures that trademark holders are notified of potential intellectual property infringements indefinitely, extending beyond the original 90-day period. This service can be activated by right owners (Trademark owners or UDRP/Court Cases).

Whenever a domain name is activated in a new gTLD that matches the Ongoing Notifications labels linked to a mark recorded in the Trademark Clearinghouse, the Trademark Holder or their Agent will receive an email notifying them of the registration, enabling them to take any necessary action.

- For exact match labels generated at the time of trademark registration in the TMCH, there is no additional cost for the first 10 labels selected. These labels apply to both Sunrise services and Ongoing Notifications, and the service simply needs to be activated.
- Additional variation labels can be added to the trademark record for Ongoing Notifications only, at no extra cost. Three types of variations are accepted: containing, partial, and variation. There is no limit to the number of variations that can be added, and these come at no additional charge.

The key benefit of the Ongoing Notifications service is that it applies not only to all new gTLDs but also to legacy TLDs such as .com and .net, and a ccTLD .cv. The service is optional, allowing each trademark holder to decide whether to activate it. For more details about the variation rules, please click [here](#).
